- 4) Direct staff to advise interested parties noted above and the broader community by conducting a Public Open House to inform and seek input on the proposed duplex policy amendments and associated guidelines. Such Public Open House shall take place prior to first reading of a CWOCP amendment bylaw, in accordance with standard City procedures and practices;
