'SUSPENDED' PMPS WILL HAVE 12 MONTHS TO EARN PDUS

December 31, 2001 is a critical deadline for any PMP who was certified or re-certified prior to 1999. This encompasses perhaps half, or more, of our Vancouver area PMPs

All PMPs who fall into this category must, in order to maintain their good standings as PMPs, report at least 60 Professional Development Units (PDUs) by year's end

PMPs who do not meet requirements to maintain their certification by 31 December will have their certification status changed from "active" to "suspended." These individuals will then have another 12 months in which to complete the requirements before their PMP certification is "revoked." If you have questions regarding this matter, please contact Barbara Pattinson, PMI Certification Administrative Manager. (certmgr@pmi.org)

As has been noted in previous newsletters, it appears that the Institute is very anxious to accommodate PMPs who wish to retain the designation. All classes of points earned under the earlier, pre-1999 system can be carried forward, and PDUs can be claimed for doing one's project management work.
