PMI ANNOUNCEMENT ON "SUSPENDED" AND "REVOKED" PMPs

December 31, 2001 was a critical deadline for any PMP who was certified or re-certified prior to 1999. This encompasses perhaps half, or more, of our Vancouver area PMPs

All PMPs who fall into this category, in order to maintain their good standings as PMPs, had to report at least 60 Professional Development Units (PDUs) by December 31, 2001.

PMPs who failed to meet the 31 December deadline have now been given until June 30, 2002 to report the required PDUs. Failing that, their certification status will be "suspended", and they will NOT be allowed to use the PMP designation. These individuals will then have until December 31, 2002 to complete the requirements before their PMP certification is "revoked." Once revoked, the PMP certification can be regained only by going through the entire application process and once more passing the PMP examination.

The on-line system for reporting PDUs, at https://certificationapp.pmi.org/ has been working very effectively. PMPs who filed on-line by year end have been receiving their re-certification applications in the mail.

As has been noted in previous newsletters, it appears that the Institute is very anxious to accommodate PMPs who wish to retain the designation. All classes of points earned under the earlier, pre-1999 system can be carried forward, and PDUs can be claimed for doing one's project management work.

Up to 20 PDUs earned in 2001, in excess of those required for re-certification, can be carried forward into the next three-year re-certification cycle. See

STRICTLY VOLUNTEER - YOUR ROLE IN THE SOCIETY

Volunteer PMs for each event, presenters, facilitators and Society Officers for next year are being recruited now.

Unless a volunteer Project Manager steps forward from the ranks of the local PMPs, a seminar does not proceed. We do have a list of some volunteer PMP presenters, but more are needed, as are volunteers to facilitate the workshop discussions which will follow the presentations.
