PD DAYS PLANNED FOR 2003

Seminar participants can claim seven PDUs for the day. We now have confirmation from PMI on the PDUs that presenters, facilitators, and the PM can claim, in addition to the time they spend as participants.

AND OTHER FAVOURABLE RULE CHANGES

With the publication of the new Continuing Certification Requirements Handbook earlier this year, the start of one's certification cycle is now the date of initial certification, rather than the first day of the next calendar year. This means that PMPs can claim PDUs for qualifying professional development activities during the year of initial certification and for the next three full calendar years in the first recertification cycle.

For subsequent recertification cycles, PMPs can carry over up to 20 PDUs from the last year of the previous cycle, provided the carry-over PDUs are surplus to the 60 PDUs needed for the previous cycle.

Also, the new Handbook confirms that practitioners are entitled to claim 5 PDUs per year for continuing to practice project management, Category 2H, and that up to 15 PDUs per cycle can be claimed for self-directed learning activities, Category 2 SDL.
