PD DAYS PLANNED FOR 2003

The minimum goal of the Society is to hold three Professional Development Seminars in each calendar year. This allows a Vancouver area PMP to meet the re-certification requirements from this source of PDUs alone.

PMP RETIRED STATUS
PDUs FOR NEW PMPs
AND OTHER RULE CHANGES

PMP Retired Status

~~~~~~~~~~~

PMI has announced a "PMP Retired" status for PMPs whose primary income is no longer derived from project-related employment or services. PMPs in good standing for at least 10 consecutive years. can apply for this new distinction. PMP Retired status will entitle individuals to recognition in the registry of PMPs and to participate in activities of the PMI Certification Program, but retirees will not need to meet requirements of the PMP Continuing Certification Requirements program.

## Advance your Certification Renewal Date.

Once you complete all required Professional Development Units (PDUs) for your current CCR cycle, you will be approved to receive the Application for Certification Renewal. In the past, the Application for Certification Renewal was not mailed out until the final six months of the CCR cycle. This change in procedure should be completed during the first six months of 2003.

Your CCR cycle expiration date will not change regardless of when you complete your CCR during your cycle. As a result of this change, many PMPs will get their updated/renewal certificate package significantly in advance of the cycle dates to which it applies. The sooner you submit your PDUs, the sooner you get your renewal package. Since there will be a fee for renewal next year (see below) you may want to take advantage of this new rule.

# Processing Fee for Certification Renewal in 2004

Effective 1 January 2004 PMI will implement a processing fee for certification renewal. Renewing PMPs will be charged this fee once during each Continuing Certification Requirements cycle. Payment will be required with submission of the Application for Certification Renewal once you have completed your PDUs. The amount of the certification renewal processing fee will be announced at a later date.

Start Earning PDUs Immediately After Certifying

With the publication of the new Continuing Certification Requirements Handbook last year, the start of one's certification cycle is now the date of initial certification, rather than the first day of the next calendar year. This means that PMPs can claim PDUs for qualifying professional development activities during the year of initial certification and for the next three full calendar years in the first recertification cycle.

For subsequent recertification cycles, PMPs can carry over up to 20 PDUs from the last year of the previous cycle, provided the carry-over PDUs are surplus to the 60 PDUs needed for the previous cycle.

Also, the new Handbook confirms that practitioners are entitled to claim 5 PDUs per year for continuing to practice project management, Category 2H, and that up to 15 PDUs per cycle can be claimed for self-directed learning activities, Category 2 SDL.
