OUTLINE

The Construction Industry has reached a high level of maturity in project management techniques, especially in the areas of procurement and the range of delivery options. PROJECT DELIVERY OPTIONS - Bryan McConachy, P.Eng, PMP. A review and discussion of alternative project delivery methods and the relative advantages and disadvantages of each one. Examples will come from the construction sector but with Project Management Principles that can be applied to any project type.

STARTING BUILDING PROJECTS - WORKING WITH OCCASIONAL OWNERS - Chris Quaife, PMP. This interactive discussion will examine how Project Managers work with owners who do not have the knowledge or resources to lead projects and how Project Managers can support and advance projects at the early stages when budget and resources are often limited.

Registration Policy - Fine Print

For the April 28, 2008 seminar we tried a lottery system rather than first-come-first-served to determine who gets to register for the seminar. The trial was successful and we received very positive feedback from the registrants.

For the September 24, 21008 seminar we shall once more use a lottery to determine which applications for registration are chosen for acceptance, in accordance with the rules set out below.

At the conclusion of an initial registration period, ending midnight September 8, 2008, a random draw will be made to assign priority numbers to all the applications received. The priority sequence will determine who is registered and the order on the wait list. Any subsequent applications will go to the end of the list in order of receipt.

Registration for a seminar does not open until a registration notice, such as this one, is broadcast. There is no provision for advance registration. Only those applications received after the time of broadcast will be considered.

Each application received by the Registration Manager prior to midnight September 8, 2008 will be assigned a random priority number. Applications will be accepted for registration in priority sequence until the registration limit is reached. The remaining applications will be placed on a wait list in priority sequence. Each application received after midnight September 8, 2008

will be assigned the next sequential priority number in the order it is received

Each application will be acknowledged and each acceptance will be confirmed by email.

Each application received will be considered a firm offer to register and to pay the full fee. Cancellations will be accepted up to midnight, Wednesday September 17, 2008. Those on the waitlist will be accepted in priority order if spaces become available prior to the cancellation deadline, and the waitlist candidate will be notified of acceptance by email. A waitlist candidate must cancel to be removed from the list.

The Society will issue an email notice of acceptance to the address provided in the registration application, but is not responsible for ensuring that any registrant has received the notification of acceptance.

Any registrant who does not show is expected to pay the full seminar fee. Accepted registrants who fail to pay the full seminar fee will be prohibited from applying for registration at future events until the payment is received.

Payment by cheque is preferred. Cash is accepted; please try to bring exact change. No credit cards or Interac (debit cards) are accepted.
